I agree that I will accompany and supervise the activities of my guests and minor children at all times.

Waiver & Release of Liability

In consideration of being permitted to use the property, facilities, staff, equipment and services of Rancho Rinconada Recreation & Park District ("RRRPD"), I, for myself, my heirs, personal representatives or assigns, do hereby waive, release, and discharge RRRPD, its directors, officers, employees, and agents from liability for any and all claims or damages, including those caused by the negligence of RRRPD, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in activities, swim team, classes, camps, observation, and use of facilities, premises or equipment. I agree that this Waiver and Release is also signed by me on behalf of all minor children of which I am the parent or guardian, and on behalf of my guests or anyone gaining entrance to the pool through the use of my membership.

Indemnification and Hold Harmless:

I also agree to indemnify and hold RRRPD harmless from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees, which arise out of my membership or use of the property, facilities, staff, equipment or services of RRRPD, or that arise out of such use by any minor children of which I am the parent or guardian.

Acknowledgment of Understanding

I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily and intend it to be a complete and unconditional waiver and release of all liability to the greatest extent allowed by law. I agree that this Agreement will be signed by all persons over the age of 18, and on behalf of all minor children of which I am the parent or guardian.

Photo Policy

RRRPD reserves the right to photograph facilities, activities, and program participants for potential future use. All photos will remain the property of Rancho Rinconada Recreation and Park District and may be used for publicity or promotional purposes only.

Assumption of Risks

Swimming and physical activity, by its very nature, carry with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from minor injuries such as scratches, bruises, and sprains to catastrophic injuries resulting in death. I know, understand, and appreciate that these and other risks are inherent in the activities made possible by RRRPD. I hereby assert that my participation in these activities is voluntary and that I knowingly assume all such risks.

Medication Policy

I understand it is my responsibility to give the medication directly to the program staff in the original prescription container. In all cases, the recommended dosage of any medication will not be exceeded. If after administering medication there is an adverse

reaction, I give my permission to Rancho Rinconada Swim Camp to secure from any licensed hospital, physician and/or medical personnel any treatment deemed necessary for immediate care. I agree to be responsible for payment of any and all medical services rendered. I recognize and acknowledge that there are certain risks of physical injury in connection with the administering of medication to this participant. In consideration of Rancho Rinconada Swim Camp administering medication to, I do hereby fully release or discharge Rancho Rinconada and its employees from any and all claims from injuries, damages, and losses I or my child/ward may have, arising out of, connected with, incidental to, or in any way associated with administering of medication. I further agree to indemnify, hold harmless and defend Rancho Rinconada and its employees from any and all claims resulting from injuries, damages, and losses sustained by me or the named participant and arising out of, connected with, incidental to, or in any way associated with the administering of medication. The camp staff will do everything possible to support a camper in complying with taking medication as directed in the information provided. However, a camper cannot hold the camp responsible for noncompliance.

Swim Camp Policies

Cancellation

A \$10 processing fee will be assessed for any cancellations, transfers, or switch of attendees.

The following timetable will be used to determine the refund amount.

Cancellations with six or more weeks' notice are eligible to receive a 100% refund.

Cancellations within four to six weeks of the camp are eligible for 75% credit or a 50% refund.

Cancellations within four weeks of the start of camp are eligible for 50% credit.

Once a program begins, we cannot make any adjustments or offer any credits without a doctor's note.

Once the program is a week away we will start to take a portion of your deposit due to an increase in late cancellations.

Cancellations within 4-7 days before the start of camp will result in \$25 being taken out of your deposit.

Cancellations within 1-3 days before the start of camp will result in \$50 being taken out of your deposit.

Cancellation the day of or no-show no calls will result in \$75 begin taking out of your deposit.

Deposit

A \$100 deposit is due at the time of registration for Swim Camp. Fees such as late pick-up or the lunch fee will be deducted from this deposit. The remaining funds will be refunded after all the camp sessions are concluded.

Early Drop Off

Rancho Rinconada Swim Camp begins at <u>8:30 am</u> and starts accepting drop-offs at <u>8:20 am</u>. If a child is to arrive before this time a flat \$5 fee per child will be applied to your account.

Late Pickup

Rancho Rinconada Swim Camp extended care begins at 3:30. All children are expected to be picked up by a parent or authorized guardian by 3:35 pm if they are not signed up for extended care. Rancho Rinconada Swim Camp extended care ends at 4:30 pm, all children must be picked up by this time. If a parent is late for extended care pick up the first 10 minutes is a flat \$5 fee per child, and the time following is \$1 per minute. Consistent late pick-ups may lead to dismissal from the program. If a parent/guardian arrives after 3:35 pm, families will be charged the single-day extended care fee of \$15 unless discussed otherwise.

Please call if you are going to be late. Rancho Swim Camp will call the emergency contact numbers after 30 minutes. If a camper has not been picked up within 1 hour of the designated time and the emergency contact still can't be reached, staff may contact the Sheriff's department to pick up the child.

Lunch Fee

If your child arrives at camp without a lunch and one cannot be brought for him or her before the designated lunch time, they will be provided with a lunch by the camp for a \$5 fee, which will be deducted from the incidentals deposit. Please note **this is not** a replacement for packing lunch and should not be used as a lunch service. Regular failure to provide a packed lunch with your child at drop-off will result in consequences. All matters concerning the failure to pack a lunch, fees, and consequences will always be discussed with the parent and never the child.

Dress Code

Camp t-shirts are mandatory every day. If a child comes to camp without his/her camp shirt we will lend them a shirt. A \$5 laundry fee will be deducted from your deposit for each occurrence. Additional shirts are available for purchase at the office.

Camp Rules

- 1. Never leave the camp area without a counselor.
- 2. Be polite, courteous, and respectful to all participants, staff, and equipment at all times.
- 3. Refrain from causing harm to self, other participants, and staff.
- 4. Use equipment, supplies, and facilities properly.
- 5. Refrain from using curse words and derogatory phrases.
- 6. Stay with the group.
- 7. Listen quietly while others are speaking and wait for permission to speak.
- 8. Follow directions the first time they are given.
 - *All rules must be followed at all times by all camp students

Standards of Conduct

Rancho Rinconada Swim Camp has a **Zero Tolerance Policy** against disruptive behavior, physical aggression, violence, disrespectful behavior towards others or their property, theft, smoking, drugs, alcohol, or possession/use of dangerous items will not be tolerated and could result in **immediate dismissal from the program with no refund**. If it is discovered after camp ends someone violated the standards of conduct, they will be prohibited

from attending camp the next camp season. No refunds will be administered for early dismissal/suspension. Damage to equipment due to misbehavior will be at the expense of the parents.

Bullying

Camp Administration has a zero-tolerance policy pertaining to physical actions against others, stealing, bullying, cyberbullying, and disrespect of staff and property. Rancho Rinconada Swim Camp reserves the right to suspend or terminate a camper's participation at any time for failure to adhere to the rules and values of the camp.

Authorized pickups

For the safety of your child(ren), they may be picked up from camp ONLY by those individuals specified by you in writing on the authorization release
form. All authorized persons must show a picture ID or some type of valid identification, which will be requested by Rancho Rinconada Swim Camp
staff. In emergencies, a telephone call authorization may be acceptable.
